SUSANNA ZAMMATARO

**Deputy Director General: IRF / Theme Champion for
Environment and Climate within the Global Transport Knowledge Partnership (gTKP)**
'Preserving road infrastructure: addressing the climate change challenge'



As Environment Expert within the International Road Federation (IRF), Susanna Zammataro is responsible for the overall environmental programmes and activities run by the IRF office in Geneva and of which the development of a Greenhouse Gas Calculator for road infrastructure (CHANGER) is certainly one of the leading projects. Appointed Deputy Director General (IRF Geneva) in January 2009, she has represented the Federation at high level meetings in Africa, Asia and Europe.

Susanna began her career in Brussels as a consultant for a European Economic Interest Grouping (EEIG) and later served as European Affairs Manager for the Italian Entrepreneurship Association (Confindustria). She joined the Delegation of the European Commission in Geneva in 2002 and successively integrated the United Nations Conference on Trade and Development (UNCTAD).

Before joining the IRF, she was leading the environment section of a research project run by the University of Geneva. Susanna is actually also the Theme Champion for Environment and Climate within the Global Transport Knowledge Partnership.

'Road preservation in Africa: lessons, realities and prospects'



Peter Freeman is an independent consultant recently retired as Lead Evaluation Officer at the World Bank Independent Evaluation Group (IEG) responsible for ex post assessments of all the Bank's transport projects. He is author of the book 'A Decade of Action in Transport: an Evaluation of World Bank Assistance to the Transport Sector.' Peter is regarded as a leading expert on transport evaluation, and is a member of several prestigious international scientific committees.

Peter joined IEG from South Africa in 2003. He has many years of both operational and evaluation experience in infrastructure in developing countries and was formerly Group Head: Infrastructure at the Development Bank of Southern Africa, and Business Development Manager at the Council for Scientific and Industrial Research in Pretoria.

Peter holds a doctorate in transport economics and a master's degree in business economics from the University of South Africa. He is a Fellow of the Chartered Institute of Logistics and Transport and author of many books and articles.

LOUW KANNEMEYER
South African National Roads Agency (SANRAL)
'The current state of South Africa's road network'



The South African National Roads Agency Limited, SANRAL, is an independent, statutory company of which the South African government, represented by the Minister of Transport, is the sole shareholder and owner. The Agency has a distinct mandate – to finance, improve, manage and maintain the current national road network of 16170 kilometres (the "economic arteries" of South Africa).

As Road Network Manager at the South African National Roads Agency Ltd (SANRAL) Mr Kannemeyer is responsible for the strategic management of the national road network of South Africa. As Road Network Manager he has gained extensive experience in the validation of monitoring equipment, network performance data collection and validation, economic and financial feasibility studies, asset preservation strategies and the formulation of the 5-year rolling works program for the national road network of South Africa.

'Why do we still need to think about how to preserve Africa's road network? What are the missing pieces of the jigsaw?'



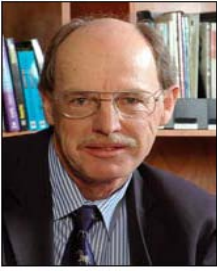
As Sector Manager for Transport in the Africa Region since 2003, Sanjivi Rajasingham is responsible for the Bank's transport lending and policy advice in all Sub-Saharan Africa countries where the Bank is active. Transport activities include highways, secondary and rural roads, concessioning of ports, airports, railways, and civil aviation regulation.

Prior to this assignment Mr. Rajasingham was responsible for the trusteeship role of the World Bank with regard to the International Development Association (IDA) and the Global Environment Facility (GEF). His responsibilities include managing the policy dialogue on IDA and GEF with donors, promoting donor contributions to IDA and GEF, overseeing the management of IDA's liquid assets, and participating in the periodic replenishment negotiations of IDA and GEF.

Earlier, Mr. Rajasingham was principal financial officer in the Latin America and Caribbean region where he headed Bank/IDA projects in private sector development, infrastructure financing, and project finance. He was responsible for designing the Bank's partial risk guarantee when the instrument was first introduced, and has also worked extensively in debt restructuring, corporate finance and in the Bank's Treasury.

'Road classification and access management: what authorities need to know'



John Sampson is a civil engineer (Traffic and Transportation) of 38 years standing. He has a BSc (Civil Engineering), MSc (Transportation Engineering), BCom (Economics, Business Economics, Industrial Psychology) and a PhD.

*John is currently Managing Director of **Transportation and Traffic Technology Africa (Pty) Ltd (TTT Africa)**, Chairperson of the Board of Directors of the **Road Traffic Management Corporation**, a Director of the **Road Traffic Infringement Agency** and a Roads Expert for the **Gauteng Transport Management Authority**.*

He has contributed to and co-authored publications such as the SADC Road Traffic Signs Manual, National Guidelines for Road Access Management in South Africa, the Gauteng Roundabouts Design Manual, the Gauteng Transport Study GTS 2000, Municipal Engineering Services Contributions Policy, and a Policy for Traffic Impact Assessments. His PhD thesis on Warrants for Traffic Signals is now an industry standard.

John has designed, or advised on, numerous projects locally and internationally. Major projects include the Gauteng freeway and strategic road system, the Gauteng Strategic Public Transport Network, future cities such as Modderfontein, Waterfall, and Twenty One, the entire Johannesburg traffic signal system, the Zambian Roadsip program for the World Bank, economic feasibility projects in Swaziland and the Platinum Highway, John Ross and Chapman's Peak toll road projects.

BACKGROUND

The conference is organised by the SOUTH AFRICAN ROAD FEDERATION (SARF) in co-operation with the INTERNATIONAL ROAD FEDERATION (IRF) and is the next regional conference in a series that is held every four years. The previous conference, the 3rd IRF/SARF Regional Conference, was held in Durban in September 2006.

The South African Road Federation is proud that this 2010 conference coincides with SARF's Diamond (60th) anniversary. The Federation's AGM will take place at the venue on the Tuesday evening, 11th October 2010 and all SARF members are urged to attend.



OBJECTIVES

Road networks throughout sub-Saharan Africa have led to significantly increased road user costs and increased death and injuries from incidents and collisions caused by poor road conditions. There is thus a compelling need for road authorities within this region to take pre-emptive steps to assure the preservation and development of road networks on the subcontinent.

This conference will bring together political and executive decision-makers as well as professionals and researchers in the roads field to examine the state of the African road network and identify means to redress the situation through efficient delivery, management and cost effective operations.

CONTINUING PROFESSIONAL DEVELOPMENT

shopping at the Waterfront before heading up the coast to Blouberg for a walk on the beach and that 'postcard view' of Table Mountain.

6) Hermanus and the whales - Over the Hottentots Holland mountains, we visit an old bakery and dentist's rooms before reaching Hermanus and a chance to see whales in the bay. Lunch is followed by a scenic coastal drive back with further whale-watching opportunities.

Workshop 1: Road safety solutions for Africa

According to WHO's 'Global Status Report on Road Safety of the World Health Organisation : *Time for Action*' (WHO, Switzerland, 2009), almost half of those who die in road traffic crashes globally are pedestrians, cyclists or users of two-wheelers – collectively known as “vulnerable road users”. Furthermore, more than 90% of the world's fatalities on roads occur in low- and middle income countries, which has less than half of the world's vehicles. This again highlights the need for strategies and implementation plans aimed at improving road safety in these countries.

The objectives of this international workshop will be:

- * Sharing of local, regional and international best practices in successfully reducing fatalities and serious injuries through specifically selected case studies;
- * Highlighting solutions which have been tried and tested and which are applicable to developing and emerging countries;
- * Focussing on the importance of community participation in identifying hazardous locations and how to make them part of the solution;
- * Targeting vulnerable road users in the development of road safety plans.

The aim of the workshop will be to follow a practical approach and to guide participants through processes which will lead to implementable plans. Road safety plans which are developed will also focus on the importance of education, awareness and law enforcement. Typical road safety measures which can be implemented will be discussed and their applicability will be demonstrated.

The workshop will be of particular interest to:

- Roads agencies
- Public sector decision makers
- Representatives from municipalities involved in road safety
- Community leaders
- Government officials from departments involved in road safety, such as Transport, Roads, Community Safety and Education
- Traffic and safety engineers and planners
- Road safety auditors

- Traffic law enforcement officials
- Academics and students
- Police, health care and emergency service providers
- Community development specialists

- Educational, Training and Research Institutes

Biography : Hilton Vorster

Hilton Vorster is Bus Rapid Transit Project Leader in the Transport and Roads Department of the City of Tshwane Metropolitan Municipality, South Africa. He has been in the road and stormwater field since 1980 and has implemented many major roads projects varying from roads for township development to major arterial roads. He has an Honours Degree (Engineering) in Transportation and has served on various committees for the updating of technical guideline documents and manuals, and in 1988 became involved in the traffic engineering field and initiated many traffic calming projects, road safety audits, accident analysis, traffic flow improvements, safety master plans and community participation sessions. Mr Vorster is currently Chairman of the Safer Roads Working Group of the International Road Federation and the Road Safety Committee of the South African Road Federation.

Governance, the act of conducting the policy and affairs of a state or organisation, generally refers to the processes by which institutions are managed, controlled and held accountable. From the perspective of a delivery agency, governance is about maximising value, subject to financial resources and legal obligations; whilst from a taxpayer's perspective it is about ensuring accountability. As such, the framework for governance reflects a balance between institutions' internal incentives and the external forces (notably policy, legal and regulations) that govern their behaviour. For example, in South Africa the King Report on Corporate Governance provides guidelines for ensuring good governance in both the public and private sectors.

This workshop will examine whether governance capacity can be assessed in a relatively objective manner for a range of transport related issues such as, public and private sector capacity, transport policy, safety, rural and urban road management, and road user advocacy. Proposals for assessing the capacity of government in the transport sector draw on practical analyses in South Africa and elsewhere over the previous 20+ years. It will focus on the context of developing countries, with a focus on the roads sector. However, the issues discussed also have a broader relevance to many other sectors of an economy.

The workshop will be facilitated by Mr. Mark Thriscutt who has been an independent consultant for 20 years and who specialises in 'soft' issues associated with transport management; and Dr. Malcolm Mitchell who, during his more than 50 year experience in the transport sector, occupied a position at the highest levels of government.

The workshop is primarily aimed at:

- Senior political and executive decision makers in the public and private sectors; and
- Academics involved in the transport sector

Biography: Mark Thriscutt

Mark Thriscutt, who has worked extensively with government bodies as well as international donors, has a degree in Civil Engineering and an MBA. He is currently based in Uganda where he is providing advice in many transport management issues, and is the governance theme champion for the Global Transport Knowledge Partnership (gTKP) with the International Road Federation.

Biography: Dr Malcolm Mitchell

Malcolm Mitchell has two transport related doctorates (in Transport Engineering and Transport Economics) as well as a Masters degree in Public Administration, all of which contained significant elements of governance. During his long and distinguished career he led efforts to establish the South Africa National Roads Agency (SANRAL), as well as an investigation into the evaluation of the performance of four government transport agencies
